

# WEATHERIZATION ASSISTANCE PROGRAM: APPLICATION FOR SERVICES

*Inter-Tribal Council of Michigan, in partnership with Bay Mills Indian Community*

Inter-Tribal Council of Michigan (ITC) received funding from the Energy Foundation to develop a Weatherization Assistance Program that provides Bay Mills Tribal citizens access to energy efficiency upgrades and energy-saving heating and cooling systems for free. This program will primarily focus on installation of heat pumps and geothermal technology, and will prioritize households utilizing propane.

Phase 1 of this project will evaluate homes for energy efficiency and need for weatherization. Phase 2 of this project will focus on identified energy efficiency and weatherization upgrades. Phase 3 of the project will focus on installation of energy-saving heating and cooling systems. ITC will serve as the liaison between the selected contractors and the Tribal citizens who sign up to participate in the program. Household-specific bids/proposals developed by a contractor will be jointly approved with the property owner. ITC will inspect the properties upon project completion.
